b. Resolution #2023-0029 -Appointment of Career Firefighter.

On motion of Commissioner Keyes, seconded by Commissioner Turner, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, there exists a vacancy in one of the career firefighter positions with the Victor Fire District;

WHEREAS, an interview committee was formed to review and evaluate candidates for the position of paid firefighter pursuant to the requirements of New York State Civil Service Law and the procedures of Ontario County Civil Service;

WHEREAS, after a thorough interview process, the interview committee recommends the appointment of Maxwell Mahoney to the position of Firefighter/Administrative with the Victor Fire District; now, therefore, it is hereby

RESOLVED that, based on the recommendation of the interview committee, the Board of Fire Commissioners hereby appoints Maxwell Mahoney to the position of Firefighter/ Administrative, effective March 9, 2023 on a full-time probationary basis at an annual salary of \$45,760;

RESOLVED that Mr. Mahoney may be employed on a part-time basis prior to his full-time appointment at an hourly rate based on his annual salary for the hours agreed upon by Mr. Mahoney and the Treasurer for training purposes; and

RESOLVED, that a copy of this resolution be forwarded to Ontario County Civil Service, and Mr. Mahoney.

c. Resolution #2023-0030 -Authorization for Career Firefighters to Attend Training

On motion of Commissioner Turner, seconded by Commissioner Barry, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, prior to receiving a permanent appointment as a firefighter from an open competitive list, individuals are required to complete a basic fire training program certified by the State Fire Administrator as meeting the requirements of Part 426 and 427, pursuant to General Municipal Law §209-w and Civil Service Law §58-a;

WHEREAS the Victor Fire District Policies require training opportunities where costs or fees are involved must be authorized by the Chief and approved by resolution of the Board of Fire Commissioners prior to attendance;

WHEREAS the next training opportunities that meet Parts 426 is the Gates Fire District Recruit Firefighter Training Program starting March 27, 2023;

WHEREAS the Gates Fire District has accepted a request to include Firefighter Max Mahoney in their program, which they have indicated the cost will be at or less than the quoted cost of attending the New York State Fire Academy;

WHEREAS the Board of Fire Commissioners have reviewed these requirements and finds that attending Gates Fire District RFFT is timely, necessary, and in the public interest; therefore, now, be it

RESOLVED the Board of Fire Commissioners authorizes Firefighter Max Mahoney to attend this training;

RESOLVED to authorize Chief Mark Eifert the authority to sign all agreements necessary for this training;

RESOLVED that the expenses for this training will be assigned to A3410.403.13 – Training – Paid FF; and,

RESOLVED that a copy of this resolution be delivered to Gates Fire District.

d. Resolution #2023-0031 –Appointment of a Grantwriter for Records Grant

On motion of Commissioner Barry, seconded by Commissioner Keyes, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, there exists through the NYS Archives Local Records Management Improvement Fund opportunities for grants to support a variety of the required records management functions of a local government;

WHEREAS, the Board of Fire Commissioners, upon the recommendation of Treasurer McAdoo, which is described in Attachment A, recognizes the need to inventory and organize the existing records and to develop a Needs Assessment and Action Plan to ensure the efficient organization and storage of these records;

WHEREAS, the Board of Directors of the Victor Fire Department, Inc., have expressed willingness to share in this process with the records available to them; and

WHEREAS, General Municipal Law §103 provides that a governing body may award a Contract without public advertising for competitive bidding where the nature of said Contract is in the form of a professional service; therefore, be it

RESOLVED that Ann McDonnell Miller is hereby appointed to provide grantwriting services for the preparation and submittal of to 2023- 2024 NYS Archives Local Records Management Improvement Fund as indicated in the contract dated December 15, 2022, which is described in Attachment B;

RESOLVED that the Board of Fire Commissioners authorizes the District Secretary to sign any documentation, including applications, to submit for said grant; and,

RESOLVED that the Board of Fire Commissioners adopts the Hazard Communication Program and directs that it be added to the District Policy Book; and,

RESOLVED that a copy of the attachments be made available to the members and staff of the Victor Fire District.
