WHEREAS, Town Law 176 and best practices of a Fire District requires adoption of various policies and forms;

WHEREAS the Board of Fire Commissioners understand that New York State requires agencies who are responsible with supplying public water to account for unusual and abrupt changes to the usage of the water system; and

WHEREAS, it is necessary and appropriate for firefighters to use hydrants for training and truck maintenance; now, therefore, be it

RESOLVED that the Board of Fire Commissioners adopts the Water Usage Report described in Attachment A and directs the Chief, line officers, and firefighters to submitted the completed report for non-incidents within 24 hours of use of a hydrant; and,

RESOLVED that a copy of this attachment be made part of the District Policy Book

d. Resolution #2023-0048 -Authorization to Attend NYSAFC Regional Hands On Training.

WHEREAS, the New York State Association of Fire Chiefs is presenting a three-hour regional hands-on training event in Bristol, NY on May 6 and 7, 2023;

WHEREAS, Firefighters Tom Simonds and Evan Haggett have expressed interest and availability in attending the May 6 class and Chief Eifert has authorized their attendance; and,

WHEREAS, the Board of Fire Commissioners approved attendance via email from April 25 through April 28; now, therefore, be it
