a. <u>Resolution #2024-083 - Purchase Authorizations</u>

On motion of Commissioner McConnell, seconded by Commissioner Keyes, the following resolution was adopted: 4 Ayes; 0 Nays

WHEREAS, the Board of Fire Commissioners received an email request on August 19, 2024, to replace the carpet in the center office area and the inc office with LVT at the cost of \$5,550, while the room are empty for new furniture and painting;

WHEREAS, the majority of the Board of Fire Commissioners replied to the email in the affirmative to proceed with the work;

b. <u>Resolution #2024- 084-Authorization of Chairman to Sign Sales Order Update for</u> <u>Rescue Truck</u>

WHEREAS, in Resolution #23-125, the Board of Fire Commissioners awarded the bid for the purchase of a heavy rescue fire apparatus in the total amount of \$1,303,695;

RESOLVED, that the Board of Fire Commissioners accepts the revised price of the bid in the total amount of \$1,326,724; and it is further

RESOLVED, that this approval is contingent upon the successful completion and approval of the resolution and the required permissive referendum process for use of the District's reserve funds which will provide the purchase of the apparatus
