c. Resolution #2024-126 - Transfer of 2024 Unexpended Funds to Reserve

On motion of Commissioner Barry, seconded by Commissioner Keyes, the following resolution was adopted: 3 Ayes; 0 Nays

WHEREAS the practice of the Victor Fire District is to provide an analysis of the expenditures at the budget years' end and to move any surplus of funds into reserves so as to ensure long term fiscal responsibility;

WHEREAS Treasurer McAdoo has provided an updated 2024 Budget Worksheet, attached to the Treasurer's Report, showing \$1,459,310 in appropriations against \$1,344,710 in expended and unexpended balance for the 2024 funds, resulting in a surplus of \$114,600;

WHEREAS, in order to maintain fiscal responsibility, the Board of Fire Commissioners desires to move a portion of the unexpended 2024 funds to reserves; now, therefore, be it

RESOLVED that the Board of Fire Commissioners directs that a portion of the unexpended 2024 funds to be transferred to reserves as follows:

A3410.901 Apparatus Repair and Replacement \$ 35,000

A3410.902 Building Repair and Replacement \$ 35,000 A3410.903 Equipment Repair and Replacement \$ 40,000; and,

RESOLVED directs the Treasurer to transfer these funds within ten days of the approval of this resolution.

d. Resolution #2024-127 - Accept Bid Results, Sale of Equipment.

On motion of Commissioner Keyes, seconded by Commissioner McConnell, the following resolution was adopted: 3 Ayes; 0 Nays

WHEREAS, pursuant to Resolution 24-122, which declared a list of PPE ("the equipment") surplus and to be sold to the highest bidder;

WHEREAS, the District Secretary advertises the sale of the equipment via sealed bid submitted by December 13, 2024, at which time 1 bid was received and opened by the District Secretary;

WHEREAS, the Board of Fire Commissioners reviewed the bid, which are more fully described in Appendix A, and determined that Cheshire Fire Department is the highest responsible bid at \$7,108.80; now, therefore, be it

RESOLVED that the Board of Fire Commissioners awards the sale of the equipment to Cheshire Fire Department;

RESOLVED that the Board of Fire Commissioners directs the Treasurer to complete any necessary documentation and release the equipment after confirmation of receipt of funds.
