a. Resolution #2025-068 - Appointment of FF 276 as Permanent Employee.

On motion of Commissioner Palmer, seconded by Commissioner Matteson, the following resolution was adopted: 3 Ayes; 0 Nays; 1 Abstain (Barry)

WHEREAS, Ontario County Civil Service Rules, Ontario County Local Law Number 8 of 1977, provides that all career firefighters shall serve a probationary period of no

more than 64 weeks from the date of hire prior to being appointed as a permanent employee;

WHEREAS, Firefighter Gokey was appointed on a full-time probationary basis on July 31, 2024;

WHEREAS, Chief Lamarco recommends that Firefighter Gokey be appointed as a permanent employee; now, therefore, be it,

RESOLVED that the Board of Fire Commissioners appoints Firefighter Gokey as a permanent employee, effective July 6, 2025; and,

RESOLVED that the Treasurer shall file with Ontario County Civil Service notice of this action.

b. Resolution #2025-069 - Motion to approve budget transfers

c. <u>Resolution #2025-070 – Authorization to enter into Professional Service</u> <u>Contract for Design Services</u>

WHEREAS the committee tasked with the bunk and quartermaster room renovations requested design services to efficiently design the bunk room layout within the existing space without mechanical changes to the building;

WHEREAS Nate Rozzi Architects has provided an estimate to provide such services;

WHEREAS, the Board of Fire Commissioners have reviewed the proposed contract, which are fully described in Appendix B; now, therefore, be it

RESOLVED that the Board of Fire Commissioners authorizes entering into a contract with Rozzi Architecture for design services;

RESOLVED, that the expense be assigned to A3410.406.5 – Building Maintenance and Repair; and,

RESOLVED, that the Treasurer is authorized to sign any necessary document to execute this contract.

d. Resolution #2025-071 -Authorization to Release Request for Proposals for Interior Finish, Flooring, and Painting.

WHEREAS, the approved Building Capital Plan designated the existing quartermaster and bunk rooms to be renovated in 2025;

WHEREAS, the Board of Fire Commissioners have reviewed the RFPs and finds them is consistent with the objectives of the District; now, therefore, be it

RESOLVED that the Board of Fire Commissioners authorizes the Secretary to advertise and solicit for the RFP as indicated.
