WHEREAS, the Board of Fire Commissioners duly adopted the 2026 Proposed Budget on September 9, 2025, and filed & provided notice as required by law;

WHEREAS, by Resolution No. 25-19, the Board of Fire Commissioners authorized an override of the real property tax cap for the 2026 Budget;

WHEREAS, the Board of Fire Commissioners held the public hearing for the 2026 Budget on October 21, 2025; and,

WHEREAS, the Board of Fire Commissioners have carefully considered, discussed, and modified the budget, taking into account all comments received, and have determined that the proposed appropriations are necessary for the safe and efficient operation of the Fire District in 2026; now, therefore, be it

RESOLVED the Board of Fire Commissioners hereby approves and adopts the Final Budget for 2026; and,

RESOLVED that the Fire District Secretary is hereby directed to file the 2026 Final Budget as required by law.

WHEREAS, in Resolution #25-75, the Board of Fire Commissioners accepted the resignation of the District Secretary appointed at the 2025 Organizational Meeting;

WHEREAS, pursuant to Town Law §174(2), the Board of Fire Commissioners is authorized to appoint a replacement to serve for the remainder of the unexpired term; and

WHEREAS, after a thorough interview process, the interview committee recommends the appointment of Karla Kirk to fill the remainder of said unexpired term; now, therefore, be it

RESOLVED that based on the recommendation of the interview committee, the Board of Fire Commissioners hereby appoints Karla Kirk to the position of District Secretary for the remainder of the unexpired term, effective December 1, 2025, at an annual salary of \$47,840;

RESOLVED, that Ms. Kirk may be employed on a part-time basis for training purposes prior to her full-time appointment at an hourly rate based on her annual salary for the hours agreed upon by Ms. Kirk and the Treasurer; and

RESOLVED, that upon Ms. Kirk's assumption of the office of District Secretary on December 1, 2025, the temporary appointment of Sean McAdoo to that position, as set forth in Resolution #25-76, shall be deemed concluded.

Special Chief Report:

Chief Lamarco informed the Commission that the Victor Farmington Ambulance will begin positioning an ambulance at the Victor Firehouse starting in November. No changes to the current Memorandum of Understanding (MOU) are anticipated at this time.
